the Public Service**

BY the Honourable Dr Joseph Muscat, KUOM, BCom, BA (Hons.), MA (European Studies), PhD (Bristol), MP, Prime Minister.

WHEREAS article 110 of the Constitution of Malta provides that power to make appointments to public offices and to remove persons holding or acting in any such offices shall vest in the Prime Minister, acting on the recommendation of the Public Service Commission;

AND WHEREAS it is further provided in the same article that the Prime Minister, acting on the recommendation of the Public Service Commission, may delegate in writing any of the aforementioned powers to such public officer or other authority as may be specified in the Instrument of Delegation;

AND WHEREAS by Instrument of Delegation dated 25th January, 1966, the Prime Minister, acting on the recommendation of the Public Service Commission, delegated certain powers in respect of the Malta Police Force to the Commissioner of Police;

AND WHEREAS by Instrument dated 20th February, 1970, the Prime Minister, acting on the recommendation of the Public Service Commission, delegated to the then Administrative Secretary certain powers respecting appointments in the Public Service on the basis of the results of public examinations conducted by the Board of Local Examinations;

AND WHEREAS by Instruments dated 6th October, 1999, and 11th January, 2005, the Prime Minister, acting on the recommendation of the Public Service Commission, delegated to Permanent Secretaries the power to make engagements on definite contract of Casual Substitutes and to renew their engagement, subject to certain conditions;

AND WHEREAS by Instrument dated 18th January, 2000, the Prime Minister, acting on the recommendation of the Public Service Commission, delegated to the then Permanent Secretary at the Office of the Prime Minister the power to make appointments to posts in Salary Scale 20 in the Public Service, provided that such appointments are made in accordance with paragraph (c) of sub-article (2) of article 110 of the Constitution;

AND WHEREAS by Instrument dated 4th April, 2009, the Prime Minister, acting on the recommendation of the Public Service Commission, delegated to Permanent Secretaries the power to engage/re-engage retired persons/retired officers up to the age of 65 years on definite contract for not more than 42 months, in areas of acute shortage as decided upon by the Principal Permanent Secretary;

AND WHEREAS by Instrument dated 26th June, 2012, the Prime Minister, acting on the recommendation of the Public Service Commission, delegated to the Permanent Secretary charged with the Ministry responsible for Education the power to make engagements of 'Adult Educators', and to renew their engagement;

AND WHEREAS by Instrument dated 26th June, 2012, the Prime Minister, acting on the recommendation of the Public Service Commission, delegated to the Permanent Secretary charged with the Ministry responsible for Education the power to make engagements of 'On call Supply Learning Support Assistants' and 'On call Supply Kindergarten Assistants', and to renew their engagement;

AND WHEREAS by Instrument dated 3rd May, 2013, the Prime Minister, acting on the recommendation of the Public Service Commission, delegated to Permanent Secretaries the power to recruit disabled persons in the

4. is-setgħa li jsiru hatriet f'karigi ufficjal ta' artikolu 110 tal-Kostituzzjoni, hlief għal pozizzjonijiet ta' *headship*, għandha tigi delegata lis-Segretarji Permanenti, sakemm tali hatriet isiru wara process kompetitiv ta' għażla u fuq baži ta' ordni ta' mertu valida,

5. is-setgħa li jiġu posposti hatriet li għalihom jirreferi paragrafu 4 għandha wkoll tigi delegata lis-Segretarji Permanenti;

Public Service in Salary Scales 16 – 20 (both scales included) directly from the register of disabled unemployed kept by the Employment and Training Corporation (ETC), following a selection process carried out by the recruiting department amongst potential candidates referred to the department by the ETC on the grounds that, in the ETC's judgement, they could be considered suitable to perform the duties, in essence, of the office to be filled, notwithstanding that such candidates would not necessarily be in possession of the eligibility requisites normally required for that office, and provided that the ability of such candidates to perform the duties, in essence, of that office, was proven through an entry examination or test of competence;

AND WHEREAS by Instrument dated 28th May, 2013, to be superseded by a fresh Instrument with modified parameters, the Prime Minister, acting on the recommendation of the Public Service Commission, delegated to the Commission the power to make and to postpone appointments to public offices below senior management level, and power to withhold the progression of public officers in the same salary scales from one scale to the next within the same grade;

AND WHEREAS the Public Service Commission has recommended that, as from 1st February, 2016:

1. the delegation of powers made by the Instrument dated 20th February, 1970, the Instruments dated 6th October, 1999 and 11th January, 2005, the Instrument dated 18th January, 2000, the Instrument dated 4th April, 2009, the Instrument dated 26th June, 2012 in respect of the engagement of 'Adult Educators', the Instrument dated 26th June, 2012 in respect of the engagement of 'On Call Supply Learning Support Assistants' and 'On Call Supply Kindergarten Assistants', and the Instrument dated 3rd May, 2013 should be revoked;

2. the Instrument of Delegation superseding that of the 28th May, 2013 should apply concurrently with this Instrument and may be exercised by the Commission in situations where the current Instrument cannot, for any reason, be applied;

3. the Instrument of Delegation dated 25th January, 1966 should be saved and should remain in force;

4. the power to make appointments to public offices under article 110 of the Constitution, other than headship positions, should be delegated to Permanent Secretaries, provided that such appointments are made following a competitive selection process and on the basis of a valid order of merit;

5. the power to postpone appointments to which paragraph 4 refers should also be delegated to Permanent Secretaries;

10. is-setgħat delegati permezz ta' dan id-Dokument għandhom jiġu eżerċitati skont id-dispozizzjonijiet tar-Regolamenti dwar il-ħatra tal-Kummissjoni dwar is-Servizz Pubbliku (L.S. 6. the power to extend fixed-term appointments or renew such appointments for subsequent terms should be delegated to Permanent Secretaries, provided that any appointments so extended or renewed were initially made on the basis of a competitive selection process;

7. for the purpose of this Instrument of Delegation, a competitive selection process may take place either following a call for applications or from among candidates referred by the Employment and Training Corporation, subject to such eligibility requirements as may apply, and according to any applicable general and special directives issued as specified in paragraph 10;

8. the power to fill a position by lateral appointment without the need for a competitive selection process, as provided for in article 25 of the Public Administration Act (Cap. 497), should be delegated to Permanent Secretaries;

9 for the purpose of this Instrument of Delegation, "Permanent Secretaries" includes the Principal Permanent Secretary;

10. the powers delegated by this Instrument should be exercised subject to the provisions of the PSC Appointments Regulations, any provisions of any other law that may apply, and any directives and guidelines issued by the Commission or by the Principal Permanent Secretary with the approval of the Commission;

11. the powers delegated by this Instrument may otherwise be exercised without reference to the Commission; and

12. the above mentioned delegation of powers should be subject to the proviso that the Commission reserves the right to make, at any time, a recommendation to the Prime Minister that this Instrument of Delegation be withdrawn or amended and that, upon such a recommendation being made and until the Prime Minister acts upon such a recommendation, the powers delegated by this Instrument shall be suspended;

AND WHEREAS I agree with the said recommendations:

NOW, THEREFORE, I, JOSEPH MUSCAT, KUOM, BCOM, BA (HONS.), MA (EUROPEAN STUDIES), PhD (BRISTOL), MP, Prime Minister, in exercise of the powers conferred by article 110 of the Constitution, do hereby direct that as from 1st February, 2016 the powers set out in paragraphs 1 to 12 herein be delegated to Permanent Secretaries in accordance with and subject to the foregoing provisions of this Instrument, as recommended by the Commission.
