BILLI l-Artikolu 110 tal-Kostituzzjoni ta' Malta jipprovdi li s-setgħa li jagħmel nomini ta' uffiċjali pubbliċi u li jneħhihom u li jeżerċita kontroll fuq persuni li jkollhom jew ikunu jaġixxu f'dawn il-karigi tkun fil-Prim Ministru, li jaġixxi fuq ir-rakkomandazzjoni tal-Kummissjoni dwar is-Servizz Pubbliku;

WHEREAS Article 110 of the Constitution of Malta provides that power to make appointments to public officers and to remove and to exercise control over persons holding or acting in any such offices shall vest in the Prime Minister, acting on the recommendation of the Public Service Commission;

U BILLI huwa pprovdut ukoll fl-imsemmi Artikolu li l-Prim Ministru jista', billi jaġixxi fuq ir-rakkomandazzjoni tal-Kummissjoni dwar is-Servizz Pubbliku jiddelega bil-miktub, bla hsara għal dawk il-kundizzjonijiet li jistgħu jkunu speċifikati fid-dokument ta' delega, kull waħda mis-setgħat imsemmija aktar qabel lil dak l-uffiċjal pubbliku jew awtorità oħra li tista' tkun speċifikata f'dak id-dokument.

AND WHEREAS it is further provided in the said Article that the Prime Minister may, acting on the recommendation of the Public Service Commission, delegate in writing, subject to such conditions as may be specified in the instrument of delegation, any of the aforementioned powers to such public officer or other authority as may be specified in that instrument.

U BILLI bid-Dokument ta' Delega datat is-6 ta' Ottubru 1999, is-setgħa li jingagġa 'Sostituti Każwali' fuq kuntratti definiti biex jimtlew vakanzi temporanji li nholqu bl-assenza ta' uffiċjali pubbliċi fuq leave twil bi hlaa jew bla hlaa eskluż leave għal mard jew leave ta' qabel l-irtirar bil-pensjoni u s-setgħa li jgedded dan l-ingagġ ta' 'Sostituti Każwali' kienet ingħatat lis-Segretarji Permanenti bla hsara għat-termini u l-kundizzjonijiet stipulati fiha u għad-disposizzjonijiet ta' Ċirkulari ta' l-Uffiċċju tal-Prim Ministru Nru. 28/99 datat l-5 ta' Mejju 1999.

AND WHEREAS by Instrument of Delegation dated 6th October 1999, power to engage 'Casual Substitutes' on definite contracts to fill the temporary vacancies created by the absence of public officers on long paid or unpaid leave other than on sick leave or pre-retirement leave and the power to renew such engagement of 'Casual Substitutes' was delegated to Permanent Secretaries subject to the terms and conditions stipulated therein and the provisions of OPM circular No. 28/99 dated 5th May 1999.

U BILLI l-Kummissjoni dwar is-Servizz Pubbliku rakkomandat li l-iskopijiet oriġinali ta' din l-iskema, kif imfissra fid-Dokument tad-Delega msemmi tas-6 ta' Ottubru 1999, jiġu estiżi hekk li jinkludi u li jinbidlu minn Sostituti Każwali fuq kuntratt ta' ghoxrin (20) siegħa fil-gimgha, uffiċjali pubbliċi li jahdmu fuq orarju mnaqqas ta' ghoxrin (20) siegħa fil-gimgha kemm-il darba:

AND WHEREAS the Public Service Commission has recommended that the original objectives of this scheme, as defined in the said Instrument of Delegation of the 6th October 1999, be extended so as to include the replacement by Casual Substitutes on a twenty (20) hour week contract, of public officers working on a reduced twenty (20) hour per week time-table provided that:

(a) Sostituti Każwali ingagġati biex jibdli uffiċjali li jahdmu fuq orarju mnaqqas ta' ghoxrin (20) siegħa fil-gimgha jkunu hekk ingagġati li jokkupaw il-perjodu li l-uffiċjali mibdula jkunu assenti;

(a) Casual Substitutes engaged to replace officers on a reduced twenty (20) hour per week time-table are so engaged to fill in the non-attendance period of the replaced officers;

(b) Sostituti Każwali ingagġati flok uffiċjali li jkunu nieqsa minhabba Leave tal-Genituri jinżammu flimkien ma' l-uffiċjali meta, u jekk, l-uffiċjali relatati jkomplu bid-dmirijiet li jahdmu fuq orarju mnaqqas ta' ghoxrin (20) siegħa fil-gimgha: f'dawk il-każi, ma jkunx meħtieġ li jidhru f'kuntratt ġdid iżda li l-kundizzjonijiet mibdula għandhom jidhru permezz ta' Addendum, mal-kuntratt oriġinali; u

(b) Casual Substitutes engaged in replacement of officers away on Parental Leave be retained back-to-back with the said officers when, and if, the officers concerned resume duties on a reduced time-table for a twenty (20) hours per week; in such cases, a new contract need not be drawn up but the changed conditions should be reflected through an Addendum, to the original contract; and

(c) Casual Substitutes replacing public officers on a reduced time-table should have their engagement suspended during the summer half-days period.

AND WHEREAS, I concur with such recommendation:

NOW THEREFORE, I Dr Lawrence Gonzi, K.U.O.M., LL.D., M.P., Prime Minister of Malta, in exercise of the powers conferred by Section 110 of the Constitution, do hereby direct that as from the date hereof, the power granted to Permanent Secretaries to engage Casual Substitutes by virtue of the Instrument of Delegation of the 6th October 1999 which, as aforesaid the Public Service Commission has recommended that should now be extended to include the replacement, by Casual Substitutes on a twenty (20) hour contract, of public officers working on a reduced twenty-hour (20) per week time-table for the duration of the non-attendance of the public officers, be so exercisable by same subject to the aforementioned conditions without reference of the Public Service Commission.
